1. Camper shall abide by all rules and regulations governing the use of the golf cart.
2. Rental age 18 yrs or older. Drivers must have valid driver's license.
3. Camper acknowledges receipt of the golf cart rental identified above. Golf cart was examined by Camper and received in a condition as agreed upon.
4. Camper shall return the equipment to office no later than the date and time specified above or upon demand. The equipment shall be returned in the same condition as when received.
5. Camper shall pay to Lessor rental fees in advance of rental.
6. Camper shall reimburse Lessor upon demand for all costs and expenses for the loss of, or any damage to the golf cart or property while it is rented, including reasonable attorney's fee incurred by Lessor in collecting amounts owed by Camper hereunder or in otherwise enforcing Lessor's rights. Schedules of charges for damages is as follows:

<b>Lost Key:</b> \$25.00	<b>Headlight/Taillight:</b> \$75.00 each
<b>Leaning to left or right:</b> \$200.00	<b>Cuts to Bench or Back Seat:</b> \$250.00 each
<b>Steering Repairs:</b> \$300.00	<b>Front or Rear Body Repairs:</b> \$500.00 each
<b>Extended Sun top Kit:</b> \$750.00	
7. Camper shall indemnify and hold Lessor harmless from and against any and all liability, including bodily injury and property damage, arising out of the use or operation of the golf cart by Camper or anyone using or operating the same with Camper's express or implied consent.
8. Golf cart to be used on campground property only.
9. Operate golf cart in a safe manner at all times.
10. Maximum of 4 individuals on cart at any given time.
11. Remove keys and engage parking brake when carts is unattended.
12. Camper shall not sublease the golf cart.
13. Golf carts returned after return time will be charge \$20 / half hour past return time.
14. Quiet hours are from 11pm to 8am. Please restrict use during these hours.
